The Work Integrated Learning (WIL) delivery of Early Learning and Care courses weaves theories with practice. Your coursework happens on-the-floor with children, colleagues, families, and the wider community.

In sharing your experiences, we will connect practice back to theory, and generate ongoing questions, and places for further inquiry.

You are expected to meet weekly (outside of your work hours) to share your learning with your classmates through a community of practice. If you are going to be absent, inform your instructor, and members of your community of practice, giving everyone as much time as possible to plan around your absence, and to generate alternative possibilities to demonstrate your learning.

You will meet regularly with your instructor, at your workplace, to share and celebrate the ways that you are demonstrating your learning.
