Intended Learning Outcomes:

Upon successful completion of this course, the learner will:

- 1. Describe ways to organize, administer and evaluate person-centred care and assistance for clients/residents experiencing cognitive health challenges (dementia).
- 2. Describe ways to organize, administer and evaluate person-centred care and assistance for clients/residents experiencing mental health challenges (other than dementia).
- 3. Demonstrate an understanding of effective approaches to disruptive or abusive behaviours.

Assignment 3 – Behavioural Case Studies 12%	Using three case studies identify problem behaviours that are being exhibited. Using Maslow's Hierarch of needs identify two basic needs that the client is unable to meet.
Assignment 4 – In-Class Exam – Approaches to Care 10%	Individual written assignment focusing on effective approaches to disruptive or abusive behaviours, administering person centred care untilising the applications of DIPPS and/or Maslow's Heirarchy.
Assignment 5 – Common Mental Health Challenge Assignment 8%	In small groups research a common mental health challenge.
