This supervised practice experience provides students with an opportunity to apply knowledge and skills to work with individuals in multi-level or complex care settings. A portion of this clinical experience will be devoted to working with individuals with dementia. Opportunity will be provided for students to gain expertise and confidence with the role of the HCA within a residential care facility.

Upon successful completion of this course a student will be able to:

- a) provide person-centred care and assistance that recognizes and respects the uniqueness of each individual client.
- b) use an informed problem-solving approach to provide care and assistance that promotes the physical, psychological, social, cognitive and spiritual well-being of clients and families.
- c) provide care and assistance for clients experiencing complex health challenges.
- d) provide care and assistance for clients experiencing cognitive and/or mental health challenges.
- e) interact with other members of the healthcare team in ways that contribute to effective working relationships and the achievement of goals.
- f) communicate clearly, accurately and in sensitive ways with clients and families.
- g) provide personal care and assistance in a safe, competent and organized manner.
- h) recognize and respond to own self-development, learning and health enhancement needs.
- i) perform the care-giver role in a reflective, responsible, accountable and professional manner.

B. Temporary Grades

Temporary grades are assigned for specific circumstances and will convert to a final grade according to the grading scheme being used in the course. Temporary Grade	Description
I	Incomplete: A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
IP	In progress: A temporary grade assigned for courses that are designed to have an anticipated enrollment that extends beyond one term. No more than two IP grades will be assigned for the same course.
CW	Compulsory Withdrawal: A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement.
