## 2. Course Description & Intended Learning Outcomes

This supervised practice experience provides students with an opportunity to apply knowledge and skills from all other courses in the program with individuals in a multi-level or complex care setting. A portion of this clinical experience will be devoted to working with individuals experiencing cognitive challenges. Opportunity will be provided for students to gain expertise and confidence with the role of the HCA within a residential care facility.

Upon successful completion of this course a student will be able to:

- a) provide person-centred care and assistance that recognizes and respects the uniqueness of each individual or client.
- b) use an informed problem-solving approach to provide care and assistance that promotes the physical, psychological, social, cognitive and spiritual well-being of clients and families.
- c) provide care and assistance for clients experiencing complex health challenges.
- d) provide care and assistance for clients experiencing cognitive and/or mental health challenges.
- e) interact with other members of the healthcare team in ways that contribute to effective working relationships and the achievement of goals.

- f) communicate clearly, accurately and in sensitive ways with clients and families.
- g) provide personal care and assistance in a safe, competent and organized manner.
- h) recognize and respond to own self-development, learning and health enhancementneeds.
- i) perform the care-giver role in a reflective, responsible, accountable and professional manner.
