#### 5. Basis of Student Assessment (Weighting)

Assignment/Percentage	Details
<b>Exam</b> <b>35%</b>	Will include all content from Units 1-5
<b>Post Tests</b> <b>10%</b>	On-line post test questions relating to the work place setting, care measures / roles of the HCA and other health care team members in both acute care and the community setting and Delegation of Tasks.
<b>Ethical Case Study</b> <b>20%</b>	In a group you will answer questions involving and ethical dilemma. Your group will then present your scenario and answers with the class.
<b>Self-Reflective Practice Assignment</b> <b>25%</b>	In a written assignment you will be expected to describe the qualities and characteristics of an ideal care provider, focusing on how the ideal HCA works independently and collaboratively. You will then compare yourself to this ideal and create some self-development needs.
<b>Resume and Cover Letter</b> <b>10%</b>	You will create a resume and cover letter based on the guidelines presented in class.

**Students must achieve a minimum of 70% to pass HCA 120 Introduction to Practice.**

## 2. Competency Based Grading System (Non GPA)

This grading system is based on satisfactory acquisition of defined skills or successful completion of the course learning outcomes.

COM	The student has met the goals, criteria, or competencies established for this course practicum or field placement.
DST	The student has met and exceeded, above and beyond expectation, the goals, criteria, or competencies established for this course, practicum or field placement.
NC	The student has not met the goals, criteria or competencies established for this course, practicum or field placement.

## B. Temporary Grades

Temporary grades are assigned for specific circumstances and will convert to a final grade according to the grading scheme being used in the course. Temporary Grade	Description
I	<i>Incomplete:</i> A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
IP	<i>In progress:</i> A temporary grade assigned for courses that are designed to have an anticipated enrollment that extends beyond one term. No more than two IP grades will be assigned for the same course.
CW	<i>Compulsory Withdrawal:</i> A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement.

### WRITTEN ASSIGNMENTS

Assignments are due before 2400 hours (midnight) on the assigned day unless otherwise specified. Assignments about patients, residents or clients must be completed using the individual's initials only. Unless otherwise directed by individual course outlines, assignments must be: word processed, double spaced, 12 font, Times New Roman font, with a title page and a reference list.

Students requiring an extension for the due date of an assignment must negotiate with the instructor, at least 48 hours before the due date. Assignments submitted late without an approved extension will result in a 5% deduction in mark for each day late.
