2. Course Description & Intended Learning Outcomes

This course provides an introduction to the role of the HCA within the BC Health Care System. Students will be introduced to the other healthcare team members. Students will also have opportunities to develop self-reflective skills required for competent practice and will be introduced to effective job-finding approaches.

- c) function in a responsible, accountable fashion recognizing legal and ethical parameters of the HCA role.

Assignment/Percentage	Details
Exam 1 35% May 31, 2021	Will include all content from Units 1-5
Discussion Postings 10%	You will post responses in D2L to scenario questions involving acute and community care.
Resume and Cover Letter 10% April 22, 2021	You will create a resume and cover letter based on the guidelines presented in class.
Self-Reflective Practice Assignment 25% May 10, 2021	In a written assignment you will be expected to describe the qualities and characteristics of an ideal care provider, focusing on how the ideal HCA works independently and collaboratively. You will then compare yourself to this ideal and create some self-development needs.
Ethical Case Study 20% May 27, 2021	In a group you will answer questions involving and ethical dilemma. Your group will then present your scenario and answers with the class.

Students must achieve a minimum of 70% to pass HCA 120 Introduction to Practice.

2. Competency Based Grading System (Non GPA)

This grading system is based on satisfactory acquisition of defined skills or successful completion of the course learning outcomes.

Grade	Description
COM	The student has met the goals, criteria, or competencies established for this course practicum or field placement.
DST	The student has met and exceeded, above and beyond expectation, the goals, criteria, or competencies established for this course, practicum or field placement.
NC	The student has not met the goals, criteria or competencies established for this course, practicum or field placement.

B. Temporary Grades

Temporary grades are assigned for specific circumstances and will convert to a final grade according to the grading scheme being used in the course. Temporary Grade	Description
I	<i>Incomplete</i> : A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
IP	<i>In progress</i> : A temporary grade assigned for courses that are designed to have an anticipated enrollment that extends beyond one term. No more than two IP grades will be assigned for the same course.
