This course offers students the opportunity to acquire basic personal care skills within the parameters of the HCA role. This course is comprised of class and supervised laboratory experiences which assist the student to develop care-giver skills that maintain and promote the comfort, safety and independence of individuals in long-term care facilities.

Upon successful completion of the course students will be able to:

- a) perform basic personal care skills in an organized manner ensuring the comfort and appropriate independence of the client/resident.
- b) apply an informed problem-solving process to the provision of care and assistance.
- c) provide basic personal care and assistance within the parameters of the HCA.
- d) provide basic care and assistance in ways that maintain safety for self and others in a long term care setting.
