## 2. Course Description & Intended Learning Outcomes

Students will develop an advanced level of practice by integrating newly acquired knowledge and skills in acute, tertiary or community settings. Students will experience interprofessional collaboration as they apply skills and knowledge to assessment, treatment, recovery, and change processes with individuals experiencing mental health and substance use challenges.

Upon successful completion of this course a student will be able to:

- a) a) demonstrate knowledge of the perspectives, values, and principles that inform leading practice and attitudes about mental health, substance use, and concurrent conditions.
- b) use a person-centered, strength and evidence-based approach as foundation for practice in community, health, and residential settings.
- c) apply comprehensive knowledge of mental health, substance use, and concurrent conditions in work with individuals, families, and groups.
- d) use critical thinking skills and evidence-based practice in the assessment, planning, intervention, and evaluation of person-centered support strategies and care.
- e) establish and maintain effective therapeutic relationships with individuals, groups, and families to facilitate change, recovery, and wellness in a collaborative and culturally respectful manner
- f) work effectively in an interprofessional and collaborative care context with individuals, families, groups, agencies, and systems.

g) practice responsibly and ethically, and demonstrate a commitment to personal and professional accountability.

#### 4. Course Content and Schedule

Student Assignments

There will be two assignments for this course. The assignments include:

Assignment One:

Reflective Journal -Value 60%

Students are required to do six reflective journals, submitted every two weeks in the drop-box. Each journal entry will be 2-3 pages long. Details will be provided in the seminar.

Assignment Two: - 40% Due date May 10th, 2019

This assignment invites you to present a case from your practicum environment to the class. The objective of this exercise is for you to discuss an issue that you are finding challenging in your practicum and on which you would like to have feedback. The class will act as your consultant. You must change the case details so that they totally protect the identity of the individual or group you are working with. You can also if you choose make up a case that approximates the kind of issues and backgrounds that you considering. The case should provide enough detail for the class to be able to consider the issues at hand. Your task is to:

- 1. Present the background of the case. Remember we need to have sufficient history, the provisional diagnostic impression and your conceptualization of the case.
- 2. A succinct understanding of the challenges facing the practitioner
- 3. Write up the case and questions as a handout for the instructors (4-5 pages). Please bring two copies to the class and upload a pdf to D2L under discussion.

The write up should include the following:

- a. Presenting problem, reason for referral
- b. Significant background information
- c. Diagnostic impression
- d. Your psycho-social formulation
- e. Treatment plan- short-term focus
- f. The challenges you are facing and reasons for consult in the form of one or two questions

Please note: If your practicum involves a project, you will be given another assignment by the instructors.

Students must obtain at least a B- in the graded assignments to pass the course.

Temporary Grade	Description
I	Incomplete: A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
