2. Intended Learning Outcomes

This course introduces the concepts of health promotion, the determinants of health, health inequities, and develops a beginning knowledge of normal growth and development. Topics include health enhancement, health protection, disease prevention, health restoration/recovery, care, and support.

- a) explain definitions and concepts related to health promotion.
- b) identify and explain epidemiology related to health promotion.
- c) explain the difference between primary, secondary, and tertiary prevention.
- d) provide examples that explain the difference between health promotion and disease prevention.
- e) discuss the major components of Canada's health care system.
- f) explain how the determinants of health impact individual health and wellness.
- g) identify health disparities between Indigenous peoples and non- Indigenous peoples in Canada.
- h) identify the determinants of health of Indigenous populations.
- i) define cultural sensitivity and awareness in health promotion.
- j) explain the principles of chronic disease management.
- k) describe teaching and learning principles for health promotion across the lifespan.
- I) describe the steps of communicable disease reporting.

- m) describe common normal growth and development theories across the lifespan.
- n) explain the concept of harm reduction.
- o) define trauma-informed practice.
- p) define health promotion principles in LGBTQ2 care.

2. Competency Based Grading System (Non GPA)

This grading system is based on satisfactory acquisition of defined skills or successful completion of the course learning outcomes.

Grade	Description
СОМ	The student has met the goals, criteria, or competencies established for this course practicum or field placement.
DST	The student has met and exceeded, above and beyond expectation, the goals, criteria, or competencies established for this course, practicum or field placement.
NC	The student has not met the goals, criteria or competencies established for this course, practicum or field placement.

B. Temporary Grades

Temporary grades are assigned for specific circumstances and will convert to a final grade according to the grading scheme being used in the course. Temporary Grade	Description
I	<i>Incomplete</i> : A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
IP	<i>In progress</i> : A temporary grade assigned for courses that are designed to have an anticipated enrollment that extends beyond one term. No more than two IP grades will be assigned for the same course.
CW	<i>Compulsory Withdrawal</i> : A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement.
