### 2. Intended Learning Outcomes

This course examines the principles of pharmacology, application of the nursing process and clinical decision-making required to administer medications in a safe and professional manner. Various routes of medication administration are introduced and complementary, Indigenous, alternative remedies, and polypharmacy across the lifespan are also explored.

Upon successful completion of this course a student will be able to:

- a) describe the responsibility of the LPN in administration of medication.
- b) explain how drug standards and the drug legislation affect drug regulation in Canada.
- c) explain the purpose of the Canadian Drug Acts and their application to nursing practice.
- d) describe the concepts of pharmacodynamics and pharmacokinetics.
- e) identify basic terminology used in pharmacology.
- f) describe the principles of pharmacology as related to common drug actions and interactions.
- g) demonstrate competency with basic mathematical drug calculations.
- h) identify commonly used drug classification systems in Canada.
- i) explain the principles of medication administration.
- j) describe the routes of medication administration.
- k) apply the nursing process as it relates to medication administration.
- I) identify various classes of medications used to treat specific disorders/illness.
- m) identify complementary, Indigenous, and alternative therapies.

I	Incomplete: A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.		
IP	<i>In progress</i> : A temporary grade assigned for courses that are designed to have an anticipated enrollment that extends beyond one term. No more than two IP grades will be assigned for the same course.		
CW	Compulsory Withdrawal: A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement.
