This practice experience provides learners with the opportunity to integrate theory from all courses into the role of the Practical Nurse in the acute care setting and other practice areas as appropriate. Learners will focus on clients with exacerbations of chronic illness and/or acute illness across the lifespan and will consolidate knowledge and skills such as: post operative care, surgical wound management, intravenous therapy, focused assessment, and clinical decision-making in acute care settings.

- g) provide a caring environment for clients and families by connecting, sharing and exploring with them in a collaborative relationship.
- h) deliver culturally informed, trauma-informed, relational care that recognizes and respects the uniqueness of each individual and is sensitive to culture and diversity.
- i) demonstrate teaching and learning through a continuum of care and discharge planning.
- j) provide leadership, direction, assignment, and supervision of unregulated care providers in the acute care setting.
- k) advocate for and lead change reflective of evidence-informed practice.
- identify how interactions with client and other members of the health care team are influenced by own biases, values and assumptions.
- m) seek out and engage in continuous learning to maintain and enhance competence.
