- **5. Basis of Student Assessment** Three components:

A. eportfolio

Students will create an e-portfolio based on their Capstone (ICS298) project. Your group will create one portfolio for your project. The e-portfolio must contain:

- 1. a public portion and at least one password protected portion. The password protected part(s) must follow good practices which will be specified on d2l.
- 2. a search feature.
- 3. a social media or blogging feature with content added throughout the term.
- 4. at least 2 search engine optimization techniques.

B. SEO – Search Engine Optimization & Tracking

Students will learn about search engine optimization techniques by studying provided reading materials posted on d2l. Search engine optimization techniques will be applied to their eportfolio (see **A.4.**) Also, students must achieve 75% on an online test based on the provided reading materials.

C. Online Ethics

Students will learn about online ethics by studying provided reading materials posted on d2l. Students must achieve at least 75% on an online test based on the provided reading materials.

B. Temporary Grades

Temporary grades are assigned for specific circumstances and will convert to a final grade according to the grading scheme being used in the course. Temporary Grade	Description
I	Incomplete: A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
IP	<i>In progress</i> : A temporary grade assigned for courses that are designed to have an anticipated enrollment that extends beyond one term. No more than two IP grades will be assigned for the same course.
CW	Compulsory Withdrawal: A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement.
