- how to define basic Java Swing components JPanel, JTextBox, and JButton
- the benefit of employing a Model-View-Controller architecture in a software application through the Java Swing framework
- how to resolve a syntax error in the NetBeans IDE
- how user interface component actions in Java Swing are handled through the ActionListener class

Lab 4:

- how to use NetBeans IDE to debug and troubleshoot Java run time errors
- that Java interfaces are used to build new class definitions
- how the MVC architecture design is implemented in a Java Swing application
- how the JUnit tool are used to build test cases
- that Java generic class Stack can be used to create a simple RPN calculator

Lab 5:

- create a MVC-pattern Java application using NetBeans Swing components
- use the Java Foundation classes to read information from a text file

- implement JButton, JTextField, JPanel, JFrame, JLabel components
- construct listener classes for the Java Swing interactive components
- using GitLab to preserve project work

Lab 6:

- building upon previous lab work to implement additional panels, error-checking, and new business-logic functionality
- add in dialogs, spinner, and a combobox Java Swing control
- provide additional error checking
- using GitLab to preserve project work

Lab 7:

- add menu elements to the application to provide additional functionality
- using build scripts to construct an application automatically

Lab 8:

• integrate an Oracle database back-end as the model instead of the text file.

Temporary Grade	Description
