#### Conduct

#### Attendance

- Be fully dressed and ready to go for activity classes. Students are required to make every effort to notify their instructor at the earliest possible time if they will be late or unable to attend any classes or activities.
- Show good judgment and maturity. Refrain from exhibiting negative behavior (i.e. swearing, being disrespectful towards others, etc.). Your behavior is a reflection of you, Camosun College, and students who have gone before you and students who will follow. Be a **good ambassador** for the department and the College.
- Avoid the use of tobacco, alcohol and other drugs. There is **ZERO TOLERANCE** for alcohol/illegal drugs when travelling during activities and on activity trips.

#### Travel

- Students are expected to be at the place of departure at least 15 minutes prior to the scheduled departure time.
- All students will be in their assigned rooms between the hours of midnight and 6:00 am of each day that they are representing Camosun College. No other persons, other than those registered to that room, are allowed in the rooms during those hours.
- CSEE Students are responsible for leaving rental vehicles (vans, buses, etc.) and hotel rooms in a neat and undamaged state. No items are to be removed from the rental vehicles or hotel rooms other than those brought. Any damage or loss (to vehicles, hotel rooms or any property) caused by Camosun representatives or their guests will require full repayment by the individuals responsible and may result in suspension or expulsion from their program and/or Camosun College.
- All students will be responsible for their own meals (except when previously arranged while traveling).

Participation in activities may involve the risk of personal injury. The use of equipment, facilities and premises owned and rented by Camosun College by persons participating in CSEE activities shall constitute acceptance of that risk regardless of the nature of the injury. Camosun College, its officers, employees and agents shall not be liable for any injury, loss or damage sustained or suffered by persons participating in Camosun College CSEE activities, whether caused directly or indirectly by the negligence or fault of Camosun College, its officers, employees, other agents or otherwise, and the student hereby waives any such claim. Where a parent or guardian has consented to the participation of a student in CSEE activities by signing this registration form, the parent or guardian hereby agrees to waive any claim against Camosun College which they may have for any injury, loss or damage sustained by the student and agrees to indemnify Camosun College from any claim made by the student.
